_____ \$5.00 Game Holding Permit (QUAIL ONLY) (# 025) (Holding and releasing)

_____ \$30.00 Commercial Quail Breeder (# 026) (Raising and selling)

_____ \$295.00 Resident Fur Dealer (# 037) (Purchasing, selling raw undressed hides, furs, pelts, skins of fur bearing animals or alligator products, except meat)
 (Resident Fur Dealer License requires a \$ 5,000 forfeiture bond)

_____ \$5.00 Raccoon Fur Seller (# 018) (Purchase or sell raw, undressed hides, furs, pelts, or skins)

_____ \$59.00 Commercial Fish Hatchery (# 042) (Facility capable of growing fish from eggs, fry or fingerlings for sale)

_____ \$236.00 Catch Out Pond (# 048) (Allows participants to fish without purchasing a fishing license)

_____ \$12.00 Resident Commercial Fishing (# 008) (Freshwater Fishing for the purpose of sale, or fishing with commercial gear)

_____ \$118.00 Non -Resident Commercial Fishing (# 017) (Freshwater Fishing for the purpose of sale, or fishing with commercial gear)

To purchase a Resident License, you must have been domiciled in Georgia for at least 90 consecutive days preceding the date of this application. PROOF OF SUCH RESIDENCY MUST BE FURNISHED. Such proof may be a Georgia Driver's License, a state-issued photo ID card, voter registration card, or automobile registration. Allow 2 to 4 weeks for processing.

O.C.G.A. 16-10-20: "A person who knowingly and willingly makes a false, fictitious or fraudulent statement...in any matter within the jurisdiction of any department or agency of state government...shall, upon conviction thereof, be punished by a fine of not more than \$1000 or by imprisonment for not less than one nor more than five years, or both."
