## LIFETIME SPORTSMAN'S LICENSE

The Georgia Department of Natural Resources, in accordance with Ga. Code 27-2-3.1(e) hereby establishes the following regulations governing the acquisition and possession of a Resident Lifetime Sportsman's License.

1. For purposes of this license, "resident" is defined as continuous domicile within Georgia for a period of 12 consecutive months or longer.
2. Applications may be submitted in person at any Wildlife Resources Division office. Proof of identity and residency will be required upon submission of application. Acceptable proof of identity shall be a valid Georgia Driver's License, a valid official state I.D. card, issued through the Department of Public Safety, military I.D. card or photo ID issued by any governmental agency or private employer.
3. Acceptable proof of residency shall be one of the following: federal or state tax form from year previous to year of application; voter registration card; automobile registration; warranty deed to same property shown on driver's license.
4. Lifetime Sportsman's Licenses shall be valid for the life of the named individual, regardless of subsequent residency status.
5. Lifetime Sportsman's Licenses are not transferrable. Fees paid for Lifetime Sportsman's Licenses are not refundable; *except* that fees paid for Infant and Youth licenses are refundable upon the death of the named licensee prior to his/her 16th birthday, and upon submission of a certified copy of an official death certificate **and** surrender of the original license.
6. In the event a Lifetime Sportsman's License is lost, stolen or destroyed, a replacement can be obtained upon payment of a \$10 replacement fee.
7. The Lifetime License must be in the possession of the named licensee while engaging in any activity covered under the license.
8. The Lifetime Sportsman's License covers the following activities: hunting, fishing, trout fishing, big game hunting, primitive weapons hunting, Georgia waterfowl hunting (Lifetime License DOES NOT eliminate the requirement for a Federal Duck Stamp) and wildlife management area hunting/fishing.
9. It is unlawful to acquire a Lifetime Sportsman's License under false pretenses. If a Lifetime Sportsman's License is deemed to have been acquired fraudulently, such license will be seized and the fees paid for such license will not be refunded under any circumstances.
10. In accordance with GA. Code 27-2-30, fees paid for Lifetime Sportsman's Licenses shall be used to fund the Wildlife Endowment Fund. This fund has been established to support, in perpetuity, wildlife management programs of the Department.
